



Potential Investor Portfolio for Friss Frass Shop, Inc. (FFS) a mutual-benefit nonprofit Cooperative.

The premise of this proposal letter is to give the investor an insight and overview of FFS's current status and growth opportunities in San Diego County.

FFS has obtained a TAX ID and SOI for the State of California, which allows us to provide a Medical Marijuana service to qualified Members as a Mobile Retail Outlet (delivery service) in all areas of San Diego County and the State of California.

Currently our delivery service is actively up and running in accordance with all the guidelines that are required to be upheld with in the San Diego County in San Diego California. Our next goal is to secure the new permit required to operate per the recent approval of Prop 64.

Our goal is secure One Million Dollars long-term that will allow us to operate and expand growth opportunities in Delivery, Franchising, Marketing, i.e. Publications, Media and Cultivation which would increase overall sales. We will open our very own Store Front (Medical Marijuana Dispensary) this year in San Diego County.

FFS shorter term goal is to acquire between one hundred and two hundred thousand dollars for immediate assistance in the Marketing arena, and for making our own Edibles/Food and for the equipment necessary to Cultivate our own Flowers (product) which is important for the growth of our company as well as a huge cost savings, by not having to purchase Flowers and Edibles from outside third parties. A 50k down payment to our legal Consultants who are responsible for obtaining our City of San Diego MMJ License and property zoning rules that will allow us to legally own and operate a Medical Marijuana Dispensary in California.

FFS is currently is a non-profit company, what that means that shares or percentages cannot be distributed at this time until the City License is issued. All investments will be structured as a loan to the business with a position on the Board. When the City Licensed is granted, FFS will start another entity S-Corp type company and formally select a Board of Directors to oversee the non-profit. Company profit sharing and percentages would then be offered and issued to any and all investors in the form of a Cap Table.

However there are caveats in the language that allows us to withdraw funds against the company until the license is issued. Please keep in mind that this is a long-term investment of up until 1 year from said investors monies are given to FFS although we would like the insight, assistance and input from our investment partners.

FFS is on the cutting edge and positioned to be one of the leaders in the Medical Marijuana Industry for the State of California, as long as we stay in compliance with the California State-law and continue to utilize our legal team as it pertains to all the laws of California.

Potential investors are essential to the growth and longevity of FFS; we will always maintain the high regard we have with our customer base which is growing rapidly in the San Diego Area.
